

## Advertisement for Bids

Notice is hereby given that the Creek County Board of County Commissioners on behalf of the City of Drumright /Drumright Utility Trust a Municipal Authority, Oklahoma hereinafter called the “City” or “Owner” will receive sealed written bids from qualified bidders at the County Clerk’s Office located at 317 E Lee, Room 100, in Sapulpa, Oklahoma, until 8:59 AM (CST) on the 12 day of June, 2023. Bids must be clearly marked with the bidder name, address and Bid #23-20 Curry Well Rehab/Pump, Electric and Labor. The bids will be publicly opened during the Board of County Commissioners meeting in the commissioner’s conference room beginning at 9:00 AM. Bids shall remain valid for 60 days from bid opening. Electronic bid submission will not be accepted.

All labor and materials will be supplied by the contractor. All work shall be performed in accordance with the Plans, Specifications, and contract documents prepared by owner, telephone 918-352-2631 ext 115, and on file in the office of the City Clerk for the City of Drumright, Oklahoma and Creek County Clerk’s office.

Each Bidder shall accompany his original bid with a certified or Cashier’s Check on a solvent bank located in Oklahoma or a Bidder’s Bond in the amount of five (5) percent of the amount of bid, and the same will be retained by the County on behalf of the Town until the successful bidder has entered into a written contract with the Owner and a satisfactory performance bond has been furnished. The bid deposit of the unsuccessful bidders will be returned upon the execution of the Contract and required bonds.

Each bidder shall accompany his bid with a sworn statement in writing that the Bidder has not directly or indirectly entered into an agreement, expressed or implied, with any other bidder concerning the price or amount of such bid or any bids, the limiting of the bids or bidders, the paying to anyone any money for promotion expenses, the parceling or farming out to any bidder or bidders or other persons of any part of the contract or any part of the subject matter of the bid or of the profits thereof.

Construction, Maintenance, and Statutory Payment Bonds in the amount of 100% of the contract price with a Corporate Surety licensed in Oklahoma and approved by the Owner, will be required for the faithful performance of the contract, and the bidder shall state in the proposal the name and address of the Surety or Sureties who will issue this bond in case the contract is awarded to him. The Maintenance Bond required will guarantee the repair of all damage due to improper materials or workmanship for a period of one (1) year after the acceptance of the work by the Owner.

Contract to be awarded to the lowest responsive responsible bidder after evaluation and recommendation by the City of Drumright.

This project is being supported, in whole or in part, by an INCOG REAP grant and federal award number 21.027 awarded to Creek County by the U.S. Department of the Treasury. The Owner reserves the right to waive any informality in the bidding.

The County and City reserve the right to reject any and all bids in accordance with the Oklahoma Competitive Bidding Act.

Conditional Bids shall not be accepted.
