### INSTRUCTIONS

1. Complete the application and submit to Creek County Planning Office (317 East Lee Ave., Suite 101, Sapulpa, OK 74066).
2. The County Planner shall respond to each application within (5) working days upon receiving a completed application, by either approving or denying the application, or approving with modifications or subject to the submission of additional information. If additional time is necessary to adequately assess the request, the County Planner may exercise an extension of this review period. If a request for administrative approval is denied, the applicant may appeal the decision with the Board of Adjustment, which shall processed as an application for Special Exception.
3. Submit with application:
  - A. A copy of the deed to the property.
  - B. Application review fee of \$50.00 – checks made payable to Creek County.
  - C. A site plan, at least one (1) of which is sized 11” X 17”, which includes:
    - All existing (“parent tract”) property lines and dimensions.
    - Lease site area.
    - All existing towers or other antenna support structures, buildings and other improvements and their setbacks from (“parent tract”) property lines, parking areas, driveways and their approaches onto adjacent streets or roads, and fencing and landscaping with notation describing the same.
    - Adjacent streets, street widths and existing access limitations.
    - Location of existing easements, if applicable.
    - Existing topographic character of the land including identification of the 100-year and 500-year floodplains, heavily wooded areas, and existing topography at a minimum of 10-contour intervals.
    - North Arrow and scale of drawing.
    - Date of drawing, surveyor’s seal and signature (if prepared by surveyor).
    - Owner and site plan preparer’s contact information.
  - D. Scaled profile/elevation view and supporting drawings.
  - E. Certification of a professional engineer licensed to practice in the State of Oklahoma that the existing structure will accommodate the additional antenna load without requiring structural modifications.
