Rezoning application: Commercial (C) and Industrial (I) Districts, PUD Abandonment	\$225.00 base fee plus \$8.00 per name on the Certified Title Abstract list of property owners within the 300' radius for certified mailing of public notices, plus mailing labels including names and addresses on the Certified Abstractors list.
Planned Unit Development (PUD)	\$175.00 base fee for PUDs having any combination of A, LR/HR or RMH districts for underlying zoning. \$275.00 base fee for PUDs including or having any combination of C or I districts for underlying zoning.
Minor Amendment	\$75.00
