FLOOD PLAIN DEVELOPMENT PERMIT APPLICATION

FOR PROPOSED DEVELOPMENT ON LANDS LOCATED IN CREEK COUNTY, OKLAHOMA, WITHIN A FEMA REGULATED FLOODPLAIN

TO COMPLY WITH FLOODPLAIN MANAGEMENT REGULATIONS AND TO MINIMIZE POTENTIAL FLOOD DAMAGE, IF YOU ARE BUILDING WITHIN AN IDENTIFIED FLOOD HAZARD AREA, YOU MUST AGREE TO CONSTRUCT YOUR PROPOSED DEVELOPMENT IN ACCORDANCE WITH THE FOLLOWING SPECIAL PROVISIONS:

SPECIAL FLOODPLAIN PROVISIONS

- For RESIDENTIAL structures, the lowest floor (including basement) must be elevated at least two
 (2) feet <u>above</u> the (BFE) Base Flood Elevation (100-year flood elevation). See provisions for
 manufactured homes in local regulations.
- 2. For NON-RESIDENTIAL structures, the lowest floor (including basement) must be elevated at least two (2) feet above the base flood elevation, or must be floodproofed to withstand the flood depths, pressures, velocities, impact and uplift forces associated with the 100-year flood.
- 3. For ALL STRUCTURES / <u>STRUCTURE TYPES</u>, the foundation and the materials used must be constructed to withstand the pressures, velocities, impact and uplift forces associated with the 100-year flood. A hydrologic & hydrology analysis will be required in areas where work is normally associated with a Zone A, AE, AE Floodway.
- 4. All utility supply lines, outlets, switches and equipment must be installed and elevated so as to minimize damage from potential flooding. Water and sewer connections must have automatic back flow devices installed.
- You must submit certification on the attached form(s) from a Registered Engineer, Architect or Land Surveyor, that the floor elevation and/or floodproofing requirements have been met. Failure to provide the required certification is a violation of this permit. (CERTIFICATE OF ELEVATION)
